Board of Aldermen Minutes
Tuesday, February 16, 2016

Members present; President Notte, Aldermen Allaire, Humphrey, Etori, Siliski, Donahue, Larson, Bloomer, DePoy and Davis. Also present, Attorney Romeo and City Clerk Heck.

President Notte called the meeting to order at 7:00 PM.

MINUTES OF PREVIOUS MEETINGS (February 1, 2016)

A motion was made and seconded (Allaire, Larson) approving the minutes of the previous meeting.

Motion passed.

OUTSIDE THE RAIL

Minga Dana, Marble Valley Regional Transit's Executive Director, spoke about supporting the BUS and thanking the city for their years of support.

Tim Johnson of 112 Robbins St. spoke about speeding vehicle traffic on his street and was looking for advice from the Board on where he could find help with this issue. A motion was made and seconded (Davis, Larson) to refer the complaint to the Traffic Committee. **Motion passed.**

Marilyn Griffin and Jack Crowther spoke about fluoride and their support to rid Rutland of fluoride in their drinking water.

Mike Coppinger and Cindi Wight spoke about the winter carnival held this past weekend. They expressed gratitude and thanks for the many volunteers and organizations involved in making the winterfest a great success.

Three students from Rutland High School and members of a local swim team spoke in favor of the pool question on the March Ballot, asking to support the building of an outdoor pool at White's playground.

REPORTS OF STANDING COMMITTEES

Dave Allaire; Chair, Charter & Ordinance Committee

Alderman Allaire read his committee report from Thursday, February 11, 2016. Alderman Allaire noted that his committee met to discuss passing a no-smoking ordinance on the public sidewalks adjacent to the Rutland Regional Medical Center. A motion out of committee was to recommend to the full board

to adopt the ordinance as presented with the amendment on E-Cigs and Vaping. Debate. The Board spent nearly 25 minutes debating the issue. A motion was made and seconded (Ettori, Humphrey) to amend the original motion with the amendment noting a distance of 10 feet instead of a 100. There was debate until Alderman Larson called the question. Motion calling the question passed. The motion to amend the original motion failed. Debate continued. President Notte moved to call the question when Alderman Bloomer asked for a roll call vote. President Notte asked the Clerk to call the roll.
