**Board of Aldermen Minutes**  
**Monday, March 19, 2018**

Members present; President Davis, Aldermen Notte, Humphrey, Ryan, Etori, Tommola, Mattis, Cook, Clifford, DePoy and Whitcomb. Also present Mayor Allaire, Attorney Bloomer and City Clerk Heck.

**7:00 PM BOARD OF ALDERMEN MEETING**

Clerk Heck called the meeting to order at 7:00 PM.

Mayor Allaire swore in all newly elected Aldermen.

Clerk Heck then opened the floor for nominations for Board of Aldermen President.

Alderman Notte nominated Alderman Davis as Board President. Alderman Etori seconded. Clerk Heck asked if there were any other nominations. Seeing none, Alderman Notte moved to close the nominations. Alderman Cook seconded. Clerk Heck called for a vote to close the nominations. **Motion passed.** Clerk Heck then called for the motion for Alderman Davis as Board President. **Motion passed.** Clerk Heck asked Alderman Davis to take the Chair.

***Kim Peters; Recreation Superintendent; Request for Referral***

A motion was made and seconded (Notte, Ryan) to refer the issue (restructuring of Office Administrator) to the recreation department. **Motion passed.**

After brief debate, a motion was made and seconded (Tommola, Clifford) to refer the request to Special Liquor. The motion to refer supersedes the motion to circulate. Debate followed this motion. President Davis called the motion to refer. **Motion failed.** President Davis then noted the original motion to circulate was back on the floor. There was no further debate and the motion was called. **Motion passed.**

##### ***Maplewood Convenience Store, Request, Second Class Liquor License***

President Davis introduced the request. A motion was made and seconded (Notte, Ryan) to circulate the petition for signatures. **Motion passed.**

A motion was made and seconded (Whitcomb, Etori) to move out of the Board of Control Commissioners. **Motion passed.**

#### **MISCELLANEOUS MOTIONS, RESOLUTIONS, NEW BUSINESS**

Alderman Etori noted that Sean Sargeant would be attending an RRA meeting to discuss the housing market in the city.

With no further business to come before the Board, President Davis asked Alderman Clifford for a motion to adjourn. Alderman Clifford so moved that motion. President Davis then asked Alderman Whitcomb to seconded the motion. Alderman Whitcomb seconded the motion to adjourn.
