Chairman Sargeant calls the meeting to order at 6:02 led by the Pledge of Allegiance

Motion made by Commissioner Siliski and seconded by Commissioner Brown to Approve the May 13, 2019 meeting minutes. Motion passed 3-0.

Introduction/Recognition of police department members

Nothing to report tonight, will be next week.

Public Comment

No one present to address the Commissioners. Chairman Sargeant wants to address that Officer Traverese followed up today with a complaint by Kim Peters of the Parks and Rec Department as Shelly Lutz wanted something done with reference to an assault call to from Pine Hill Park, there was an attempt of an injury with a stick.

Chairman Siliski had been contacted by resident, Bob Kelly with reference to two complaints. One was with the decision of the last dog hearing, whereas he was dissatisfied with what the outcome was and he was told that he needed to contact the City Attorney, as he thought that there was an alternative plan to send the dog to another town and Commissioner Siliski had indicated that he didn't know if Mr. Kelly could appeal the decision, as he was not the dog owner. The other issue he wanted to address with Commissioner Siliski is that he was not satisfied with the decision that he cannot own another dog until he completes a course.

Communication From the Union

Union President Jeff Warfle indicated that they are in the process of mediation with one meeting behind him with one to be reset by the NBPA. President Warfle reports that there is a Union meeting scheduled for tomorrow.

Commander's Report

Commander Sheldon reports that they have begun the park walk and talks again, as they have assigned two park walk and talks for every shift. The bike patrol is out in the parks as well as the neighborhoods.

To get the practice, there will be a table top session at Rutland Regional Medical Center on July 11 to deal with a chemical contamination.

School Resource Officer LaGuardia will be working under Sgt. Lucia on the night shift for the summer.

The post basic trainings are going very well with the three new officers. Shot gun familiarization has been done and patrol rifle familiarization will be done tomorrow with the help of Officer Williams. Advanced tactical training will begin Wednesday and on 6/23/19, they will start field training.

Sergeant's leadership training is continuing. Expectations have been outlined for Sergeants and Commander Sheldon.

Commander Lachance reports that they are down to 2 scheduled to go to the VT Police Academy in August.

Records Clerk Ryan Brady is working on the NCIC Audit results for VCIC and will be presented at the next meeting. The visitor policy needs to be updated and be in compliance with NCIC.

Det Rosario and Maguire have completed the Forensic interview mandated with children

Detectives Ashe and Maguire will be attending a Mobile device training in Woodstock

There are plans to do more interdiction next summer for Vision

The roof is now complete.

Commander Sheldon has completed the Sergeants Leadership training in house for his division and other Sgts divisions are given the option to complete.

Commander Prouty is going to Burlington with Mentor Connector Chris Holmquist to look into the possibility of a Youth Center for the Rutland region to review the Icelandic Model that is used by Burlington.

Chief Kilcullen reports the highlights tonight of the presentation for the RutStat meeting. 3Peat percentage of call volume is 14.6%, which is 13.7% of the calls that the department responds to in total in a week and a half.
