THE FIRST ISSUE DISCUSSED WAS THE
PROPOSED PLACEMENT OF THE KIOSKS, 4
ON MERCHANTS ROW, AND 5 ON CENTER ST.
Ald LARSON expressed concern with the 3rd
kiosk placed on the south side of CENTER ST
NEAR THE PARKWAY. HIS CONCERN WAS RE-
INFORCED BY WHAT HE SAID WERE CONCERNS 10

COMMUNICATED TO HIM BY SOME MEMBERS OF THE DOWNTOWN RUTLAND PARTNERSHIP.

KEVIN BLOUGH SAYS HIS RESEARCH LED HIM TO BELIEVE CAFE' RECOMMENDATIONS FOR 5 ON CENTER, 3 ON THE SOUTH SIDE, WERE BASED ON THE NUMBER OF PARKING SPACES ON THE STREET, WHICH IS THE INDUSTRY PRACTICE.

MIKE COPPINGER EXPRESSED HIS UNDERSTANDING OF THE PLACEMENT RECOMMENDATIONS, AND ALSO SPOKE OF THE LACK OF A COMPREHENSIVE PARKING PLAN INVOLVING LOTS, SPACES, AND THE PARKING DECK, WHICH ARE ALL INTER-CONNECTED

ADAM ROBERTSON EXPRESSED HIS SUPPORT FOR THE VENDORS RECOMMENDATIONS AND THE DENSITY ISSUE, WHICH WAS RAISED BY A.D. NOTTE.

AFTER SOME DEBATE INCLUDING A.D. LARSONS CONCERN WITH LOOKING OUT FOR CITY FINANCES WHICH INVOLVE FUTURE PURCHASES OF KIOSKS //

A motion was made to

Approve the current configuration of the kiosk placement as recommended by CAE' (the vendor), and that the kiosk placed by the PARADISE BE MONITORED FOR USAGE AND HAVE THE INFORMATION REPORT BACK TO THE BOA IN ONE YEAR TIME. AND I SO MOVE.

THE SECOND ISSUE WAS THE PLATE READER TECHNOLOGY TO BE USED BY THE KIOSKS, AND PRIVACY CONCERNS RAISED BY MEMBERS OF THE PUBLIC TO ALDERMAN HURPHREY. COUN. ATTY. ROMEO STATED THAT RECENT STATUTE ENACTED BY THE VERMONT LEGISLATURE REGARDING PLATE READERS, THEIR USE & STORAGE OF DATA, FALLS IN LINE WITH THE WAY THESE READERS ARE TO BE USED IN THE CASH.

ALD. HURPHREY AGREED THE PLATE READERS MAKE SENSE FOR THIS APPLICATION BUT REQUESTED FOR INFORMATION PURPOSES.

HAVE CAE' CONTACTED REGARDING INFORMATION COLLECTED BY PLATE READERS, VERIFICATION THAT THIS

CONFORMS WITH STATE STATUTE, A COPY
OF THE STATUTE, AND REPORT BACK TO
THE BOA THE ANSWERS TO THESE QUESTIONS.
